

# Long-Standing Issues Remain About Using Inventory for Management Decisions - GAO

The Government Accountability Office (GAO) has identified several long-standing issues that continue to hinder the effective use of inventory information for management decisions. These issues include:

- The lack of a comprehensive inventory system
- The inconsistency of inventory data
- The lack of timely and accurate inventory information
- The lack of training for inventory personnel

- Require agencies to develop and implement a comprehensive inventory system
- Establish standards for inventory data collection and reporting
- Provide funding for training and technical assistance to inventory personnel

By taking these actions, Congress can help to ensure that federal agencies are able to use inventory information to make better management decisions.

### **The Lack of a Comprehensive Inventory System**
